<p>What is the overall deductible?</p>	<p>Network providers: \$2,000/individual, \$4,000/individual under family, or \$4,000/family Out-of-network provider: N/a</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. The deductible is Non-Embedded. If you have other family members on the plan, the overall family deductible must be met before the plan begins to pay. Deductible year runs 06/01 – 05/31</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive care without cost-sharing and before you meet your deductible. Does this plan provide Minimum Essential Coverage? **Yes**
